Annual and life membership prices to remain the same
Pricing for member rounds to remain the same. Non-member prices will be deleted. *Everyone must sign in at the pro shop before any shooting takes place. All temporary and annual member shooters will be required to show their membership cards at the front desk before access to the fields. NO EXCEPTIONS.*

TEMPORARY MEMBERSHIPS

Temporary memberships will cost \$30.00 and will expire after 30 days. At expiration, another temporary, annual or life membership must be purchased. No credit or prorated memberships will be issued when changing membership status.

MEMBER GUESTS

Members are encouraged to invite guests without purchasing memberships. Guests must be accompanied by a member; members are responsible for guests. Each guest will pay a \$10.00 "limited daily range fee" plus target costs for each day they shoot at AGC.

Guests will sign the waiver of liability, shooter conduct and safety before access to the fields.

Guests must complete a safety instructional course directed by a Board of Director or an "on-grounds" member appointed by the Board before shooting on the grounds will be allowed. A twenty question test will be administered after a short orientation before shooting is allowed.

SAFETY AND CERTIFICATION PROGRAM

The club will present a short safety program for every shooter at AGC, including annual and life members. This is not a requirement for existing annual and life members. The program is *required* for temporary members and guests of members. This program will consist of general gun safety rules and range safety practices. In addition, each shooting discipline will be presented with specific rules and guidelines for that particular discipline. Shooters will also get a brief history of the club and how the club operates.

After the safety program, members, temporary members, and guests of members (hereafter referred to as “shooter”) must read and agree to club rules and then pass a twenty-question exam. If the test is completed satisfactorily upon the first attempt the shooter will be permitted on the range. If the test is not completed satisfactorily, the shooter has the opportunity to request remediation (i.e., retesting and hands on instruction as structured by the AGC Board.) No shooting until the test is satisfactorily passed.

RECIPROCAL MEMBERSHIPS

A valid, current membership from another ATA, TTA, NSSA, NSCA sanctioned gun club, interstate and intrastate, will be honored as a member of Amarillo Gun Club. The gun club would certainly welcome a membership to our club as we are trying to increase our membership base. This reciprocal membership is exempt from any voting rights or decision-making authority vested in the Amarillo Gun Club life or annual membership.

EXEMPTIONS TO MEMBERSHIPS

The following affiliations, clubs, associations and organizations are exempt from membership, but must fill out and complete all waivers and safety forms required by AGC, Inc. The Board of Directors will determine the requirements for safety orientation and testing pertaining to these exemptions.

ATA/ TTA, NSSA, NSCA, Boy Scouts and county 4-H clubs and any other organization approved by the Board of Directors.

CHARITY EVENTS

Participants will be considered member guests and granted permission and access to the club during the said event schedule. All participants will be required to sign all waivers and safety rules forms and agree to the safety program presentation. The presenting sponsor will be required to sign a blanket liability waiver as part of the agreement to use gun club facilities.

LEAGUES

Organized leagues fall under membership rules as stated above and must have at least one participating club member shooting in the league. AGC strongly urges all league shooters to join the gun club as a temporary, annual or life member. League members then pay target prices per round and the league itself can determine and execute its form of winner qualifications (prizes, pay outs, etc.)

MEMBERSHIP DEFINITIONS

Temporary member

30 day membership; must be renewed in 30 days with temporary, annual or life membership. Temporary memberships consist of immediate family— the member, his wife and children only.

Temporary members can invite guests; limited use fees apply.

Annual member

One year membership valid from April 1st to April 1st Annual memberships consist of immediate family---the member, his wife and children only. Annual members retain all voting rights and decision-making authority affecting the club plus participating in all club functions. Annual members are encouraged to bring guests; limited use fees apply.

Life members

A one-time purchase allows member to participate in voting, and any operational decisions concerning the gun club plus participating in all club functions. Life membership consists of the life member, his wife and immediate children. The life membership is *not* transferable at any time. The life membership is dissolved at the time of death. Life member's guests are subject to the daily use fees.

These final revisions cover all aspects of membership that the Board of Directors considers valid as of January 1, 2011. Any further changes or disputes occurring after January 1, 2011 will be discussed by the Board of Directors at the regular monthly board meetings or by special meeting as the Board specifies.
